- **4b) Update on Public Works Truck Purchase:** Mayor Thul advised that the truck is still in the process of being finished and delivered. ETA is January 2021.
- **4d) COVID-19 Cares Funds (City):** Councilor Hoehna made the motion to award COVID-19 grant funding (of which the city is allocated \$25,000 total) to the following businesses, contingent upon meeting county and state guidelines:

\*Living Favorite Stories Preschool \$5,000 and \$4,375 for a total of \$9,375

\*Long Branch \$4,375 \*Upper Crust \$4,375 \*Daisy's Central Station \$4,375 \*City Covid-19 Expenses \$2,500 GRAND TOTAL \$25,000
