**5b) Appoint City Recorder as Budget Officer:** Mayor Spurgeon motion; Councilor Harral second to appoint City Recorder as Budget Officer. All in favor, none opposed.

**5c) Code Enforcement:** Mayor Spurgeon motion; Councilor Thul second to have Mayor Spurgeon investigate possible Code Enforcement through the County, as well as obtain additional information from the City of Adams regarding their contracted Code Enforcement Official. All in favor, none opposed.

**5d) Address AWERE Board Vacancy:** Councilor Thul motion; Councilor Stephens second to appoint Mayor Spurgeon to the AWERE Board as the City of Weston representative. All in favor, none opposed.

**5e) Approve Soft Side Cab for Kubota:** Councilor Thul motion, Councilor Stephens second to approve a soft side cab for the Kubota tractor, not to exceed \$2,000.00. All in favor, none opposed.
